How to help

The Route Partnership's planning application to build on battery Rocks beach has been withdrawn but the Route Partnership are continuing to promote their scheme and have recently been lobbying Councillors from the Penzance Area. Clearly they have not given up on the scheme, and until such time as they do we are urging people to continue to object and push for an alternative to building on Battery Rocks beach. At this point it is most important that you write to your Cornwall Council member and to Tom Flanagan, the officer ultimately responsible for the scheme (see details below).

1. Write to your Cornwall Council member

Perhaps the most important target at the moment is local councillors. The Route Partnership are trying to win them over; at the moment they are for the most part against the development, but they must be reminded of the strength of local feeling. This is important because any final decision to proceed with the scheme will be taken by Cornwall Council members (your elected councillor).

2. Write to Cornwall Council

3. Object to the planning applications

The planning applications have now been withdrawn. A review of alternatives is underway and if this concludes that the original scheme is the best (and a biased report is perfectly possible) then there is a possibility that the plans may be resubmitted. For this reason if you have not already objected please do so.

4. Write to your MP

Andrew George has been instrumental in securing the funding for the harbour improvements but is concerned about the proposed scheme and unhappy with the way it was chosen. It is important that he continues to feel the strength of public opposition to the scheme. If you are in Cornwall but outside Andrew George's constituency write to your own MP.

4. Write to the Department of Transport and South West RDA

The Department for Transport (DfT) is providing funding for the harbour works and part of the cost of the new boat; they have stated that they are not bothered which scheme is chosen so long as it meets the objectives and is supported by the public locally. The DfT funding is being channelled through the South West Regional Development Agency (RDA). They can be contacted at:
